Mercury Diesel 3.0L Tier 3 Turbocharger Oil Supply Line Sealing Washers

Scope

Worldwide

Situation

Mercury Diesel has identified a situation whereby the oil supply line to the turbocharger could loosen. This issue has the potential to affect all engines, regardless of engine run time or engine service history. Loosening of the oil supply line can allow engine oil to leak onto hot engine components and can cause an odor, smoke, or, in rare cases, a fire.

Inspection

Engines reworked by the factory or by an authorized dealer will have a mark indicating that the rework has been performed. With the engine removed from the shipping container, or installed in a boat the rework identification will be a yellow dot placed to the left of the serial number decal.

Correction

- 1. Remove the engine cover.
- 2. Remove the hollow bolt securing the oil supply line to the turbocharger.

3. Remove the sealing washers on each side of the hollow bolt fitting.

4. Install new sealing washers and tighten the hollow bolt finger-tight.

Official Notification of Federal Boat Safety Act Recall

Dear Customer,

Thank you for the purchase of your Mercury Diesel power package. Mercury Diesel is dedicated to providing superior product reliability and customer satisfaction. As part of our commitment to superior customer satisfaction we have determined that your power package must be recalled under the **Federal Boat Safety Act** so an update can be performed.

What is the condition?

Your power package must have the turbocharger oil supply line updated. A loose connection on the oil supply line to the turbocharger may allow engine oil to come in contact with hot engine components. This may cause an odor, smoke, or in rare cases, a fire.

What will Mercury Marine do?

We have provided instructions to our dealers on the upgrade to be performed to these engines. This update will be performed at no charge to you.

What should you do?

Contact your Mercury Diesel dealer to arrange a service appointment. When scheduling your service appointment mention Mercury Diesel Service Bulletin 2016-71.

Please present this notice to your Mercury Diesel dealer when you bring your vessel in for servicing.
